Even if Petitioner were not barred from seeking judicial review, however, we find that he has failed to state a claim against the government for several reasons. First, Petitioner, a Mexican citizen, is barred from bringing suit against the United States because it is not a party to the Treaty, the United States is not a required party, and the United States is immune from suit. See Hill v. United States, 944 F.2d 1271, 1274 (10th Cir. 1991) (holding that an appeal to the United States Court of Appeals for the Federal Circuit was unavailable where a United States diplomat was employed by the Canadian government and was a party to the Treaty, but the United States was not a party to the Treaty). Second, with respect to the nongovernmental organizations, Section 2 of the Treaty provides that if a member government is not fulfilling its obligations or if a member government has abused its discretion in evaluating the application, a member government may request that the ICI review the matter.
